

Systematization of Capacity Development for Social Protection in Africa:

Lessons learned from the EU-Social Protection Systems Programme (EU-SPS)

Co-operation with countries and regional organizations in Africa

The EU Social Protection Systems (EU-SPS) Initiative (2015-19) has supported national and regional expert institutions in Africa in their efforts to develop inclusive and sustainable social protection (SP) systems. Local leadership, sustainability and wide participation of national and regional experts have been the core principles of cooperation: Government of Finland's National Institute for Health and Welfare (THL) has managed the EU-SPS work on Social Protection Capacity Development, which is the focus of this summary paper.

Capacity development and strengthening

THL-Finland's support has been focused on strengthening management capacities in social protection (SP) through the systematization of pre



-service and in-service capacity development through national universities, colleges, TVETs, e-learning and regional peer-to-peer learning networks and systems.

Capacity development starts with the assessment of existing capacities, assets, strengths and weaknesses. Based on a gap analysis additional contents and curricula have been developed for civil servants' inservice training and pre-service education of future generations of SP-professionals at universities, colleges and TVET-institutions.

The THL/EU-SPS has distilled <u>evidence-based</u> <u>guidance</u> from its work with country and regional partners, to guide the EU-Commission, EU Member States and other partners in their future programming of official aid for SP.
